The United States antidumping laws are set forth in Title VII of the Tariff Act of 1930, as amended ("the Act") (19 U.S.C. 1673 et seq.). Arms-length Transactions (between affiliates) Generally, the Department may use transactions between affiliates as a basis for normal value, cost of production, and constructed value only if the transactions are at arms length.
