Ordinary Resolution: This is the decision/vote of at least 51% (majority vote) of the members/board of directors of the company. Some decisions that may require an ordinary resolution include: election/re-election of directors, appointment of auditors, acceptance of financial and directors report at the general meeting, appointment and removal of directors.

#### **Resolution of a Company or Board of Directors**

Where a Directors' meeting cannot be held, the same matters can be authorized by the Directors' resolution that is signed by all the directors. Directors supervise the management of the corporation and make all major decisions for the corporation.

A Directors' Resolution is a written record of an action or decision made by a company's board of directors. The resolution can be created with or without a formal meeting of directors. For instance, if a board of directors expressly agrees to an action, a written resolution can be drawn up without a formal meeting.
