Providing holistic care to patients included care to the spirit, mind and body. Spiritual care needs to be administered and documented; however, in many instances, spiritual care and documentation of the care is greatly lacking. One barrier to the delivery of spiritual care by nurses is a lack of education regarding spiritual care. The purpose of this research project was to determine the influence of increased spiritual care education on nursing documentation of spiritual care in a long-term, acute-care hospital. The theoretical framework of the theory of human caring by Watson was chosen due to the relationship of the components of the spirit, mind, and body and how each one is interdependent on the other. Stoll's spiritual care assessment was incorporated into the education presentation. Knowles' theory of adult learning was used to deliver the information. The educational program was presented to a self-selected sample of 14 nurses and included pretest and posttest, PowerPoint presentation, and a review of the hospital's computerized documentation procedures. The nurses read two literature sources showed no change in the median scores of the pretest (90%) and posttest (90%). The chart audits completed before and after the education offering revealed no increase in the percentage of documentation of spiritual care. Implications for practice, research, and education were identified that will

promote proper documentation of spiritual care to patients.
