Tax on \$25,000 salary: taxable income = \$25,000 – \$10,350 deduction = \$14,650; income tax =  $(\$9,275 \times .10) + (\$5,375 \times .15) = \$927.50 + \$806.25$ ; total tax =  $\$6,750 + \$1,733.75 = \$8,483.75$ .
